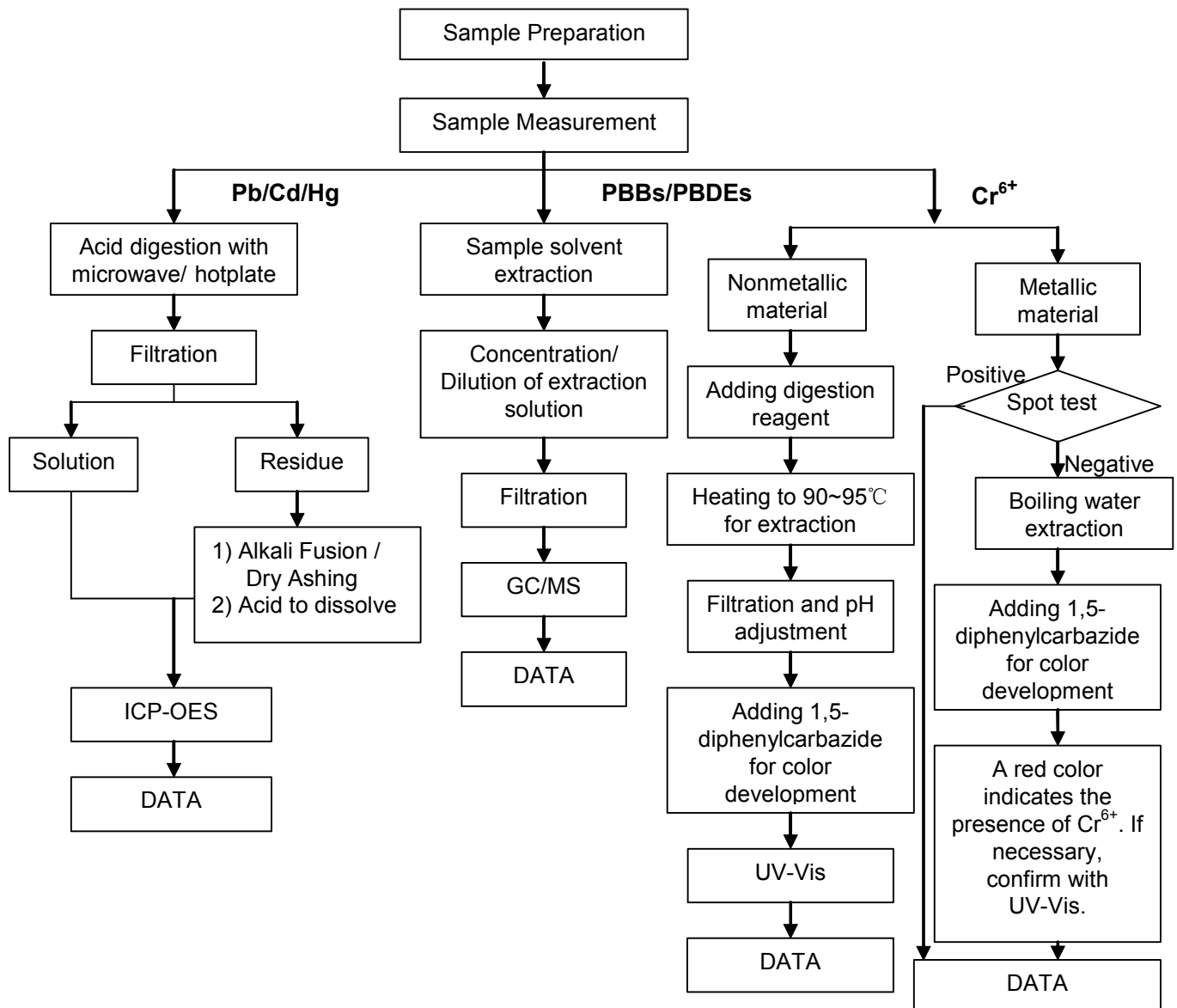

RoHS Testing Flow Chart

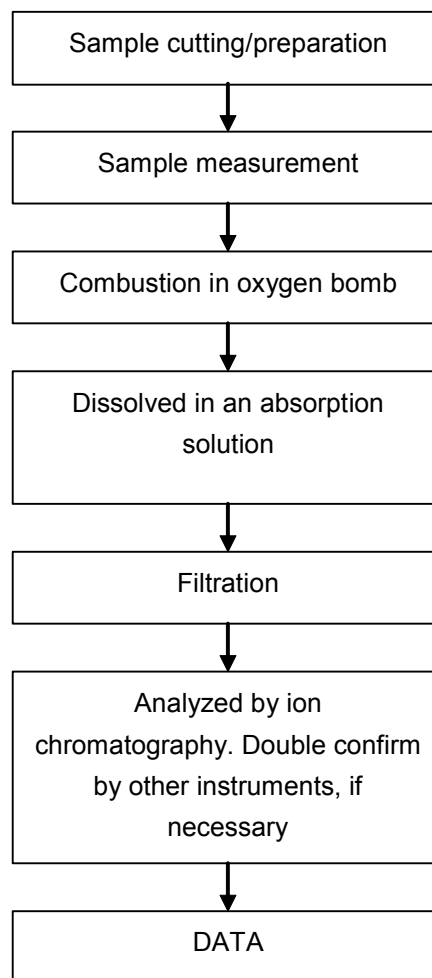

Halogen Testing Flow Chart

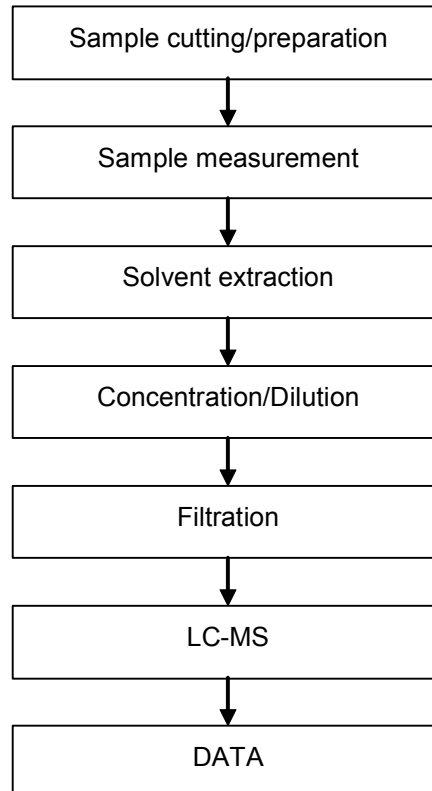
